Absolute Resource Associates (ARA) offers a full-service, certified environmental testing laboratory with a wide array of capabilities. We are a leader in utilizing technologies that provide critical data and maximize project performance while still minimizing our impact to the environment.

ARA provides analytical laboratory services to municipalities, industries, and environmental consultants in support of site investigations, contamination studies, waste characterization, discharge permits, and



disposal. We also provide water testing services to residential well owners and homeowners who are concerned with their drinking water quality.

Our services at ARA include method development, electronic data deliverables, technical project management, access to knowledgeable chemists, as well as convenience services such as sample containers, bottle order delivery, preprinted chain of custody forms, and courier service for samples. ARA provides PFAS testing to residential, municipal, industrial, and federal clients throughout the region, and contracted with NHDES to identify and quantify PFAS in environmental samples per the agency's ongoing investigation into the prevalence of PFAS in drinking water throughout the state.
- ARA has been a partner in the predesign and remedial actions at a municipal landfill, and supports many New England landfill cleanup efforts by coordinating sampling, providing preprinted chain of custody forms, bottle orders, and lab analyses.
- ARA has performed bulk sediment testing, analysis, quality control and electronic reporting in support of projects evaluating dredged materials proposed for disposal in New England waters.

# **Indoor Air Quality**

Absolute Resource Associates (ARA) provides complete management of Indoor Air Quality (IAQ) investigations. The ARA IAQ team is comprised of experts trained in industrial hygiene, microbial contamination, and indoor air quality, assisting clients with issues related to mold, lead, asbestos, Legionella, allergens, chemicals, VOCs, unidentified odors, and more. ARA's IAQ projects range from residential homes to municipal buildings, schools, hospitals, commercial/industrial buildings, and large government facilities.



The IAQ team at ARA will outline a plan designed to meet your specific needs. The process begins with a client consultation to discuss the nature of the IAQ concern and determine the best plan of action for your particular situation. ARA offers thorough building examinations, sample collection and lab analysis of suspected contaminant(s), problem identification, remediation options, as well as follow-up / clearance testing, and a personalized IAQ maintenance plan if requested.

### **ARA Indoor Air Quality: Project Experience**

- A response to complaints at a Daycare Facility regarding odors resulted in an investigation which turned up several indoor air quality contaminants, HVAC issues, unsafe carbon dioxide levels, and mold contamination. The expertise and guidance of our staff led to thorough remediation and clearance testing to bring the facility back to normal function and a much safer environment for the children and staff.
- ARA was called to investigate concerns about Legionella contamination at a large health facility. Both air and water samples were taken throughout the building, and ARA's IAQ team performed a meticulous investigation to locate all sources of contamination. A customized remediation plan was implemented, and the client was able to avoid an outbreak of Legionnaires' disease among patients and staff.
- A school facility contaminated with smoke and extensive soot following a two-alarm fire was deemed unsafe by the School Board and concerned parents. ARA was called in to evaluate the situation. After a thorough building investigation, sampling and air testing, some parts of the school were given clearance within 24 hours of arriving on site, minimizing class disruption. After further remediation and air testing, a "clearance of occupancy" report for the entire building was delivered to the School Superintendent.
- A call from the US Department of Agriculture requesting Indoor Air Quality services resulted in the extensive inspection of a Ranger Station property in New Hampshire. The building and surrounding soils were inspected for asbestos and lead. The remediated building and property were later sold with the full legal disclosure of the lead and asbestos surveys that were conducted by our team.
